Minutes of the Ordinary Council Meeting of Biggin Parish Council held at The Cream Room, Eversley Park Centre, Low Street, Sherburn in Elmet, LS25 6BA held on Wednesday 4th December 2024.

The meeting opened at 6.02pm

Present: Cllr N Kaiper-Holmes (Chairman), Cllr R Anderson, Cllr V Earle, Cllr C Hartley Cllr J Lamb and Georgina Ashton, Clerk to the Council. 20 members of the public present and NYC Cllr Andrew Lee, 2 Police Officers.

Minutes of Meeting

25/54 To receive and consider apologies for absence

Cllr Lee has provided his apologies in advance of the meeting. The Chairman wished to provide a Vote of thanks to the Clerk for all her hard work and unpaid hours spent on the additional workload created by the planning applications and unauthorised traveller site in the parish.

25/55 To receive any Declarations of Interest from Members

Members are invited to declare disclosable pecuniary interests and other interests in items on the agenda as required by Biggin Parish Council for Members and by the Localism Act 2011.

None received.

25/56 Public Participation Period

The Clerk provided an overview of the 2 planning applications and an update on the situation with regard to the Temporary Stop Notice at Bridge House, Biggin. This is imposed until 31 December 2024. Questions were raised as to what happens next once this enforcement notice expires. It was agreed that this would be raised at the meeting with NYC officers and the PC on Monday 9th December.

The Clerk talked through the plethora of documents that have been created, including a collated document of all the key documents on the portal (for the main application ZG2024/1067/FULM) and a research paper written referring to policy and similar traveller site applications across the district and county area. The GTAA (Gypsy Traveller Accommodation Assessment) 2018 states that there are 46 authorised pitches across the whole of the Selby area and the largest site is only 12 pitches (Old Great North Road site at Newthorpe with Huddlestone). Discussion over the latest update from the Highways Engineer, reported that the applicant has been written to, to reduce the hedge height to 1m to increase the visibility splays, to reduce the stone pillar height to <1m and add reflective material to the outside and to unlock the gates as a permanent egress from the site and remove the caravans from the hard standing directly behind the gates. No details were provided as to the length of time that the applicant has been afforded. This does still not meet the conditions 03 and 04 from the COU consent and the Clerk will respond to the Highways Engineer in due course.

25/57 County Cllr report – update from Cllr Lee Cllr Lee has agreed to attend the meeting Monday 9th December 2024 at 10am, with NYC Council Officers.

PCSO Hannah Price 4532, PC Richard Wood: Two Police Officers present reported on the site:

Police statutory consultee comments were read out. 7 crimes and 7 anti-social behaviours have been recorded in the last 12 months, all relating to this site. Designing out crime is critical to planning development and the officer i/c has written to Ryan King, Planning Officer: PC Richard Ball, Designing Out Crime Prevention Officer. Reminder that this is why everything needs reporting. Crimestoppers, 101, Police website – it will certainly build a bigger picture. Can "log" retrospective incidents on the police portal (online reporting is a little confusing, if you think the question is n/a, then do write that in). Can look up the NY Police website, a project called Operation Snap – vehicle crime and driving offences.
